TOURNAMENTS

RUBBER BRIDGE

- Auckland must advise NZ Bridge of the number of entries by 31st May in order to qualify for two places in the final, depending if it has the most entries
- There will be a subsidy for the winning pair for travel and accommodation to the finals at Congress in Hamilton

2010 CLUB TEAMS COMPETITION

2011 TOURNAMENT SCHEDULE

- NZB asked the ARC and WBRC their thoughts on having a major bridge event at Easter time with an idea of possibly holding the NI Pairs and Teams (two days each) at this time
- The request from NZB did not state if their idea would be a one-off for Easter 2011 or a regular Easter event
- The committee felt the idea was not acceptable as numbers at Easter are predictably low but perhaps a trial involving 2 x one-off events with suitable A Points may be well worth considering

A POINT TEAMS TOURNAMENTS

REGIONAL COMMITTEE NOMINATIONS

- Clubs to be sent a nomination form as the term for current committee expires on 30th June
 ANGELA
- The RC shall comprise no less than four (4) and no more than six (6) members who shall hold office for a term of two years commencing from 1st July in the year of appointment
- Current RC members may be nominated for a further term
- The Secretary and Treasurer may or may not be members of the RC
- If they are not members of the RC they shall not be counted for the purpose of a quorum and shall not have voting rights
- A quorum of a RC shall be three members
- If there are more than six nominations for the RC then clubs have a weighted voting right in an election in proportion to their Home Club membership
- Once constituted, the RC shall appoint by resolution a Regional Chairperson
- Nominations from clubs are required to be sent to the RC Secretary by 31st March 2010
- The new committee for 2010 to 2012 is required to be formed by 30th April 2010
- The Board of NZ Bridge appoints the Regional Committee.
