Tournaments:

Club Championships

The Chair advised the Committee that at the recent National Conference she advised there has been some concern raised that clubs in the Wellington region do not enter the Club Championship's as they believe they have little or no chance to compete against the clubs entering with strong open players. Members of the National Committee did not see this as a problem noting that it can be the Intermediate and Junior players that can win the competition for their club. Having all competitors sign a declaration to play in the finals should they win the trial was discussed.

- IP trials

The Committee noted to date two Intermediate pairs have entered the competition. Teams v pairs competition was discussed noting that some regions attending the National Conference advised that they now run the competition as a pairs event. It was agreed to consider introducing a code of conduct and participation for players to sign. Dinnie to consider if the code used by the Christchurch Club is applicable and/or can be adapted for the Wellington Region.

- Junior League Tony commented that the Junior League is working well with number up on those expected.

Moved Tony/seconded Heather - to award the "midpoint" consolation prize to the higher position of two players should there be an even number of players - agreed.

It was noted that 11 Junior Tournament have been held up to June but only four scheduled for the rest of the year. The Committee agreed that it would be better to have a more even spread of Junior Tournament throughout the year and to review the tournament schedule to see what changes can be made. Secretary to email the latest tournament schedule to the Committee. It was noted that it is difficult for the National Tournament Organiser to programme in additional tournaments, or to make changes, and that the schedule for 2016 will be finalised by NZBridge at the end of June.

 Promoting bridge - Ways to increase participating in tournaments at all levels was discussed. Noting that teams events are popular the Committee discussed how it could encourage Clubs to hold more 5A team events. Holding tournaments over three sessions and/or consecutive nights was considered.

Moved Tony/Seconded Heather – consider holding a teams event over the three days/evenings of Labour weekend – agreed.

- The Chair noted the following points from the NZBridge Conference held Saturday 13 June 2015:
 - NZBridge to sponsor youth under 30 to congress
 - The remit regarding C point changes was lost
 - There is to be a new process for recorders
 - complaints will be accumulative so that a pattern of misconduct may become apparent and action taken
 - the person making a complaint is not to be kept confidential
 - changes to the constitution will allow for a player to be banned from a tournament (clubs can do this of right)
 - They are looking at cinema advertising
- It was agreed that Paul produce the newsletter to clubs with Anthea's assistance.
