(1) **Previous Minutes**

(2) Matters Arising & Action List

(3) Finance Report

It was moved that the masterpoints for Waikato Bays and Bay pairs are to be paid for by the clubs hosting the session, commencing 2012. Carried. Martelletti/Bishop

There was a discussion on web site maintenance figure which needed to be corrected.

The amount for rubber bridge pairs was incorrect and reduced.

It was moved that the report be accepted after amendments were made for the above and a correction of the inter provincial amount. Carried. Ritchie/Driscoll

A letter of thanks to be sent to Richard Hooper for attending the regional conference on our behalf.

The report was received and taken as read.

(5) Interprovincials

The new format is underway as per the previous minutes.

(6) Rubber Update

Only 4 entries have been received to date.

Secretary to contact Alison Beer, president of the Rotorua club, to enquire if they would provide us with a copy of their wonderful notes and their scoring summary sheet so that we can supply these to the clubs in our region.

Send a reminder to clubs that the closing date is the 20th March.

(7) Championship Leagues

Monitoring of scores. Jane from Cambridge has offered to do this. Allan to liaise with Jane over this and to create a package for the clubs holding the tournaments advising what is required to be done and to remind clubs to have the score cards available.

Next tournament is Kaitkati 22nd May.

(8) Big Day Out 2

It was decided to have this as a bi-annual event. A date to be set around the tournament schedule as late as possible in 2012 – possibly 26th August. Judith to check with John Wignall to see if that date is suitable for him to attend as key note speaker.

(9) Youth Weekend 24/25 September

Ideas for a format required. Possibly at Rotorua and provide alternative team building events. To apply for funding – can the coaching grant from NZB be used?

(10) SFE National

Nothing to report – 3 people have signed up. This has not taken off, there has not been any response for mentors from other regions.

(11) 2012 Tournament Schedule – Confirmed as finalised 2013 Tournament Schedule –

It was decided that the Waikato Main Centre 10A pairs become a Waikato Bays Main centre 10A teams event.

Rona to write to the clubs who have additional events to those which are approved and advise that they are over their allowed allocation. To advise that while there is no problem with the running of these events, that they do require authorization, which we are prepared to automatically grant each year. To suggest to these clubs that they may use this as an opportunity to review their own tournament schedule.

Clubs to be advised by newsletter that when this committee calls for confirmation of dates for the 2013 tournament schedule - that if they do not confirm their dates, they may be changed at the committees discretion.

Also for the newsletter to suggest clubs combine events and give examples of how successful this has been in Tauranga, The Mount and Rotorua.

(12) Tournament Directors

20th March Ed Rogroveen may require supervision for the Waikato Pairs in Morrinsville as Nick Witten (who was supervising) may be called to Christchurch 20th March Jocelyn Major will direct the Bay pairs in Tauranga under supervision of Norm Silcock. Jocelyn is not a qualified director, but has considerable experience. All of Tauranga's directors will be away in the South Island.

(13) Youth Captains Report for 2010 IP's

This has still not been received. Judith to write to Stephen and advise that we are disappointed that he has not provided the report and that we will not be considering him in future as a IP captain.

(14) Christchurch Earthquake Fundraising Charity Tournament

It was decided to hold a simultaneous pairs event to raise money for the benefit of the Christchurch bridge club and or its members. Christchurch club to decide where best the funds to be allocated. To approach Hamilton, Rotorua and Tauranga to run the event on the 11th June. \$20 per player, the club to take minimum amount for the running of the event and at least \$10 per player to go to

charity. The clubs to provide the session prizes and the regional committee will provide an overall prize.

It was moved that the Waikato Bays regional committee will match up to \$1,000 raised by the clubs for events held on the 11th June. Martelletti/Barlcay
