The Committee discussed the appointment of Dean Sole as the Wellington Recorder. The Committee agreed, although it is not required by the Constitution, that it should have been advised prior to reading the Board Minutes that a new Recorder for the Region had been appointed.

Moved Anthea/Seconded Paul - that the correspondence as listed be accepted agreed.

## Tournaments:

- IP's Heather commented that she is receiving reimbursement claims spasmodically from the representatives.
- Christmas Cheer to be held at the Wellington Club on 12 December. The Committee discussed the budget of \$3,965 exclusive if GST for the event and that it is anticipated that there will be a small deficient of approximately \$100. As the budget for food is \$2,800 the Committee considered ways in which this could be reduced but agreed that to reduce the quality or quantity could mean reduced numbers attending. It was noted the WRBC underwrites this tournament. It was suggested that the Wellington Club be advised to increase the entry fee next year to \$45.

It was moved Heather / seconded Paul - that the 2015 Christmas Cheer budget of \$3,965 be accepted - agreed

It was moved Heather / seconded Paul – to spend up to \$50 on spot prizes for the Christmas Cheer - agreed.

Congress – It was suggested:

- to draw attention to the flyer that the header above the photo be yellow

- 72 boards over one day can be split

#### General Business:

- Youth subsidy grant to Elizabeth Schuck. Heather has deposited the grant in Elizabeth's bank account
- Sponsorship policy document (circulated prior to this agenda) as the document was not discussed comments to be circulated via email

Junior League – Tony's hard work noted

- Letter from WBC seeking financial support for holding the Ron Klinger workshops – it was noted that the request for a refund of \$245 is outside the Committee's original agreement to subsidise the Ron Klinger workshops if the required player numbers were not met. Moved Anthea / seconded Paul – That the Committee, in this instance, refund the Wellington Bridge Club \$245 (exclusive of GST) – agreed
- Clubs Meeting Sunday 21 February 2016 (draft agenda circulated along with A11 this agenda) – comments to be circulated via email
- Allan advised that the Masterton Bridge Club cancelled its tournament due to insufficient numbers. He explained that the Tournament Director went to considerable trouble to ensure she was well prepared for this tournament only to be advised shortly before the event that it had been cancelled. It was agreed that the Masterton Club to be advised:
  - if any Club applies for a tournament to be held it should proceed no matter the reason for the cancellation
  - the WRB Committee is available to advise and help to organise tournaments even if player numbers are low.
