As we have the maximum number of Committee members it is in order to coopt/appoint a further member but in accordance with NZBridge Scope and Delegation of Authority Document, the additional member does not make up a quorum nor has voting rights. This to be conveyed in letter of acceptance. Moved "that we accept Susan Sykes's offer to take up the position of Secretary/Treasurer from 1 July 2010 as a co-opted member of the CD Regional Committee". Hill/Wilson carried.
