Business:

Mini Congress - Margie Michael undertook to meet with all club committees to canvas support for the Regional Mini Congress, as well as taking the opportunity to brief the clubs on ways the committee can be of use to them & to learn of what concerns clubs have that the committee could help with.

2010 Business Plan – Margie Michael will formulate one.

Mixed Sex Pairs 3A – scheduled for April 25, and hosted by Karori Club, a budget is to be requested for committee approval. Flyers are to be sent out as close to March 12 as possible.

Regional Committee Nominations – A date & venue for the ballot is to be found. Notice will go out to all clubs as soon as the date/venue confirmed.

Club Team Championship KO & IP Trials: An invitation to quote for venue hire will be circulated to Wellington BC; Karori BC & Hutt BC, for either both events or for one.

2011 National Tournament schedule – the committee is waiting to receive this from NZBI. Greatest impact for the Wellington Region will be the earlier National Congress in July, resulting in earlier trials for IPs & Club Team Champs and a September date for the Mini Congress.
