Rangiora's Club's request for change of their Open B Tournament from 10th July to 3rd July approved. No clash with other tournaments in the region.

DIRECTORS SEMINAR

New Directors Seminar

Judith to liaise with David Skipper and Cliff Jones of Crockfords Club to arrange a suitable date for this course. Crockfords to host event. Course to target people wishing to commence directing or people with little directing experience. Once date arranged Judith to circulate Clubs in the Region to invite participation

Directors Advanced Seminar

Les Frater and Dave Putt to liaise with David Stephen and Daniel Skipper to arrange date, venue and course material.

Inter-Club Teams - Crockfords Club Hosted

Unfortunately Crockfords miscalculated catering costing for this event. Regional Committee discussed and agreed to provide a further \$220 to help defray costs. Total payment made of \$420.

Traditionally Regional Committee pays Directors directly.

Crockfords have indicated their quotation for hosting 2011 Inter-Provincials and Inter-Clubs teams will need to be revisited. Now that Top of South region has been established and travel distance is now not so great, it has been suggested that earlier start time is now possible. 10 am mooted with a break for lunch and completion by late afternoon.

Interprovincials - Team Captains' Reports

Overall results disappointing but Canterbury spirit to the fore in all teams.

Team Captains performed their duties very well.

General feeling that timeframe for Teams was rushed.

2011 Trial Format

Format should allow Teams or Pairs Format.

If Teams format followed and less than two teams entered, Regional Committee reserve right to select the team.

Following motion proposed:

"This year's forthcoming Inter-Provincial Trials will be run as a Teams of Four Event with a third pair to be selected by Regional Committee in consultation with the Winning Team."

Approved with one vote against (Michael Johnstone requested his vote be recorded)

Joan Small further proposed:

"Propose that Senior Inter-Provincial Trials be held two weeks after the Open/Women's/Intermediate Trial."

Michael advised domain name costs approximately \$20 per year. Cost \$15 per month to maintain. Establishment of page to be decided. Site to be maintained by a committee member.

2010 Charity Pairs

Men's Cup to be located – could be used as Mixed Pairs trophy.

Use of limited funds

Discussion as how to best utilize limited funds available to Region.

This year \$500 spent on Top Team and \$200 on training for Interprovincial Trials.

Need to have strategy for Development of Bridge in Region. Getting people back to tournaments an issue. More prize money? More Teams Events? Back to the Future Teams or Swiss Pairs appear popular.

Sub-committee of Les Frater and Dave Putt to investigate possibilities.

Coaching Grant

These need to be applied for before the event is held. To ensure that all Clubs have an equal excess to this fund, we will invite applications twice a year.

Skype Meeting

Executive have been holding weekly Skype meetings – Wednesday evenings at 6pm. Other committee members are welcome to join in.

Full Regional Committee Skype monthly meeting to be instigated – first Monday of each month at 7 pm. First meeting Monday 1 November 2010.

Joan Small tendered her resignation from Committee, effective 31 December 2010. Michael Johnstone thanked Joan for her contribution over the past years.
