#### TREASURER'S REPORT

Information from the commencement of the year to the end of August circulated to meeting. Current position healthy given the grants from Pub Charity and Southern Trust towards the accommodation costs of the Interprovincial representatives in Hamilton.

#### **GENERAL BUSINESS**

**Interprovincials:** The Youth and Intermediate teams performed well, made the finals. Reports received from each of the NPCs. Discussion whether NPC required for each team (this year two NPCs managed two teams).

**2012 Tournaments:** Approach has been made to the Christchurch Club regarding which tournaments they thought they may be in a position to run next year, a response showed, the Holiday pairs, 3,5, and 10 January and the Easter Congress 5A Pairs and 5A Teams, 5B Pairs and 5B Teams – this had previously become a 10A event – Michael to follow up with the Club re this.

The Regional Committee looking to circulate more information on the role of Recorders, that the Committee has zero tolerance of bad behavior at bridge — Jenny Wilkinson indicated that should a Club not have a Recorder, she could be available.

**IP Trials 2012:** Following the IPs this year, representatives were emailed to ascertain feedback on the format of the 2011 trials. Four responses received. The format had been teams – there had been indications that if the trials were in a teams format, more players would trial. This had not occurred. Discussion on the way to attract more trialists and attempt to achieve strong representation for Canterbury. 2012 trials will be in pairs format with ability to indicate 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> (if applicable) preferences – including Intermediate. Expressions of interest requested from youth players. Date set at 19 April – format and number of boards to be played, to be worked through by Michael with Arie Geursen and Patrick Carter – possibly two days involved – billeting of out of town players to be looked at.

**Club Event at Hamilton:** Jenny Wilkinson raised the issue of why there wasn't any representation from Canterbury at the Club competition at Hamilton this year. Christchurch Club had previously been the club represented but not this year. We discussed the events of the year, the fact people thought the length of the events in Hamilton very long, the cost involved in attending the Congress.
