# **Top of the South Strategic Planning Day**

#### 1 Clubs at Risk:

All clubs in good heart.

#### 2 Intermediate / Junior scorecard:

Clubs to encourage players when they are ready for tournament play. Region to look at providing trophy for Intermediate and/or Junior players Have a training day on the day after a Intermediate or Junior tournament On the hands played in the tournament

## 3 Funding Applications:

At present the Region has funding arrangements with Nelson Building Society and Pub Charity.

Most clubs have their own funding arrangements (some with NBS) NZ Bridge policies constrain the Region's ability to get business sponsorship.

Talk with Gary Howard re ongoing NBS sponsorship

Arrange bulk bidding pad deal with NBS logo for all clubs.

Ask clubs that do not bank with NBS to make an investment with it.

### 4 Playing Formats:

Richmond will not hold a Swiss Pairs this year. May do so in 2014.

### **5 Unaffiliated Clubs**

Collingwood. Many Golden Bay players. Will not affiliate Golden Bay Greymouth. Still playing bridge since disaffiliating.

### 6 Director's Exams

Tournament directors all play in A Point tournaments.

Shortage of club directors, especially at some clubs.

The status quo with directing 5A tournaments is working adequately.

### 7 Website Development

Website considered useless, unless well designed and kept updated. To set up a website with Bridge NZ will cost \$2,500. Look into having Facebook presence.

# **8 Coaching Grants**

Coaching grants are applied to clubs, not Regions. TOTS region has not yet spent its full annual \$1,000 grant. Encourage clubs to apply for grants for player and director training.

## 9 Regional Congress

TOTS Region does not have a Regional Congress.

#### **10 Tournament Liaison**

There are complaints that the tournament calendar is congested. Little room for movement; except perhaps keep open tournaments Interspersed with Intermediate and Juniors.

Suggested that adjacent clubs use the same weekend, one on Saturday and one on Sunday.

Send clubs a letter pointing out their responsibilities for tournament and appeal committees.
