### **Appointment of Lynne Fegan to NZ Bridge Board Vacancy / May 2011**

### **NZ Bridge Foundation**

Three new Trustees were appointed in April – John Wignall (MNZM), Karen Martelletti & Tony Thomson. At that same time Kris Wooles' resignation was accepted with regret. I thank Kris for his input to the setting up of the Foundation and recognise that time constraints and other commitments have meant he can no longer continue in the role of a Trustee.

### **Primary School Bridge Initiatives**

- A North Otago initiative commenced last year is continuing with pleasing results – Bridge is taught in the Maths Classes of two Primary Schools.
- A South Canterbury initiative of an after school Bridge Club at Grantlea Downs Primary School was commenced at the beginning of the 2<sup>nd</sup> Term and will continue in the third term. Year 7 & 8 children are participating.

## **Conclusion**

At this time player recruitment & retention remains the single most major collective issue being faced by NZ Bridge, its Regions and Clubs. Our collective challenge is to help increase membership of NZ Bridge by promoting the benefits of the high level mental stimulation and social engagement for all ages which Bridge provides.

The English Bridge Union recognised these benefits and set up an initiative, detailed in an article on its Website to mark its 75<sup>th</sup> Anniversary, which is outlined below.

In 2009 the English Bridge Union set up the All Party Parliamentary Group for the development of Bridge under the chairmanship of Baroness Ruth Henig. The Group has concentrated on two major areas of development.

### **1. Introducing Bridge to Primary School Children**

*The goal is to enable primary school children to experience the benefits of Bridge. Bridge helps them improve their numeracy skills, problem solving ability, probability assessment, speaking, listening, rule following, team building, mental capacity and much more.*

### **2. Research into how Bridge can protect against Dementia**

*Recent research has proven that undertaking regular mental activity such as playing bridge can significantly lower the risk of developing forms of dementia in our older population and the social interaction it offers the elderly can stave off cognitive decline."*

Developing and implementing short, medium and long term strategies focused on these concepts could provide NZ Bridge Clubs with the impetus to recruit potential members from non traditional sources. The challenge is collective and one which we must all embrace if membership of our Clubs is to grow.

### **NEW ZEALAND BRIDGE FOUNDATION**

Tony Thomson led this segment on behalf of Chairperson and fellow Trustee Jo Clark who was unable to attend. Tony summarised the activities of the Foundation over the previous year including the recent appointment of 3 new Trustees (himself, Karen Martelletti & John Wignall). Tony also presented the financial Audited financial statements for the year to March 31 2011 and outlined the activities that the Foundation had in the pipeline to attract further funds and make appropriate disbursements.

### **GENERAL BUSINESS**

#### ▪ **Management of 15A Tournaments (Auckland Bridge Club)**

Russell Watt spoke to this item voicing concerns at the Boards decision to involve itself in what the Auckland Club considered to be operational matters. Arie responded outlining the reasons why the Chief Director would be responsible for the appointment of Directors for all 15A events and would also be required to approve the Tournament Flyer and the proposed format. A discussion ensued and while not all delegates were in support the Board confirmed its policy position that the prescriptive responsibility for such events rests at national level would remain in place.

- **Central Districts Regional Committee (Hastings Bridge Club)**

Murray Wiggins spoke to this item and voiced concerns about the Boards recent decision to amend the composition of the Central Districts Regional Committee namely the removal from the Committee of Mr Gerard Palmer. Kay sought confirmation from Murray that he had discussed this Agenda Item with Mr Palmer. After advising that he had not done so Kay advised the meeting that any discussion on this item was limited to generic matters only.

Graham Wakefield responded and advised that the Board had lost confidence in Mr Palmer to represent the Board on one of its Committees. Accordingly a decision was made to remove him. Tony Thomson asked for clarification whether this decision could be reviewed or rescinded in the future.

Graham summarised the constitutional position wherein a person can not be appointed to a Board Committee without the majority of the Board supporting the nomination. Therefore while the present Board had made the current decision it was unable to indicate if majority support for a similar nomination would be available on any future occasion.

- **Central Districts Club Teams Play-Offs (Hastings Bridge Club)**

Murray Wiggins spoke to this topic and expressed his Clubs concerns that the Board had sought to interfere in the Region's Interclub Competition to determine its representative in the National Clubs Championship competition at Congress by questioning the eligibility of a member of the Hastings Club team in the Eastern zone play-offs in this event.

Graham Wakefield responded and advised that the Board had been alerted to the fact that Mr Gerard Palmer had contested the event as a member of the Hastings Team while permitted to participate in Club play but subject to a ban from Tournament participation. It was the Board view that this event was not Club play and was in fact a tournament scheduled in the Tournament Calender with an entry Flyer issued and the opportunity for Masterpoints to be awarded. The Board had investigated to clarify the factual context and had referred the information available to Kris Wooles (Chairperson- Conduct, Disputes and Discipline Committee) for further consideration.

It was agreed that the Regulations Committee be asked to update the Tournament Regulations in the Manual to ensure that the Club Championship (including any preliminary heats) is more clearly defined as a Tournament.

- **Corporate Koru Club Membership (Hastings Bridge Club)**

Murray Wiggins spoke to this topic voicing the Clubs concerns that the Board had chosen to spend the member's funds on corporate membership of the Koru Club. Alister responded and outlined the rationale for the membership. It is planned that the Board will meet more frequently and will do so using the Meeting Room facilities at the Wellington Koru Lounge. The Board members will be able to travel in and out on the day of the meeting which will see a reduction in

accommodation, meals and airport transfer costs. Alister outlined the cost of meetings where Board members are required to overnight and that the cost of the Koru membership will be covered by two such meetings being replaced by single day sessions over the coming months.

Sita Monaghan said that the proposal made good sense and she supported the Boards decision.

- **Session Times- National Congress**

Brett Glass asked that the session times at congress be reviewed to include more early finishes and less evening sessions. This suggestion to be forwarded to the Congress organising Sub Committee.

- **Timing of Congress**

Derek Snelling sought clarification to the timing of the National Congress in future years. Richard Solomon advised that the event would return to the Sept/Oct time slot from 2012.

- **Thanks to Secretary**

Allan Joseph thanked Alister for the sterling job he does as National Secretary.

- **Christchurch Bridge Club**

Neil Hawkins thanked those present for the support that the Christchurch Club and its members had received from the Bridge community of New Zealand following the Earthquakes.

There being no further business Kay Nicholas, thanked the Delegates and Observers for their contribution to the meeting.
