Confirmation of Minutes:

Matters Arising from minutes:

General Business:

- 2) It was moved that Kristen Collins be removed as a signatory to bank accounts. Kaye Wilson and James Coutts to remain and Phillip Hensman added as signatories.

- 3) Swiss Pairs review: 11 tables. \$239 for Master Points (\$199+GST). The director charged for 3 sessions (\$180) and \$100 travel. Predicted small loss of \$30.
- 4) Secretaries meeting: M. Jackson attended as our representative and provided a verbal report. Tournament schedule was discussed (see agenda #8). A Junior tournament with just 1 session was held as a trial. Majority of those playing preferred 2 sessions and playing against those of similar rank.
A Secreatry/Treasurers timetable was tabled.
- 5) Rubber Bridge:
F. Sheehy is to oragnise this. Entries to close March 25th. Kaye to amend notice.
- 6) IP trials, 2015:
Format- Butler pairs with IMPs scoring. Discuss with Dennis McCaughan/ Michael Albert. Intermediates to play separately with format decided by number of entries. Possibly Swiss Pairs?
Entry fee \$100 /person
Entrants to specify what team they are trialling for.
M. Jackson to get form for updating from Anne- Louise.
- 8) Director Training Enquiry:
Frances to discuss with Alister the possibility of having Alan Joseph run a session the day before the Regional Conference ie 28th March, or have a separate day (funded by coaching grant?). Agreement that Alan's sessions are excellent and it would be good to hold it in Central Otago.
- 9) O/S Regional Conference: Sunday 29th March
Notices with amended dates have been sent to Clubs. Also asking for 2 reps to attend. Agenda may change depending who is representing NZ Bridge -Jane Stern, Alan Joseph, Murray Wiggins?
Regional Issues need to be identified for final session eg Interclub teams.
