#### 2016 – 2017 Annual Accounts Review.

Gail McIntosh reviewed our accounts. Her findings were distributed prior to the meeting. There were a couple of recommendations for next year:

The records of committee minutes and cash book are once again prepared very well which makes my job easy. There is no evidence supporting the receipt of some monies from NZ Bridge – IP travel grant etc. but this isn't an issue as they are direct credits.

The festival is generating a lot of cash/cheques (\$3,620) and it would be advisable to encourage all participants to pay by internet which is easier for the organisers to manage. Also in future I'd like to see a list of the recipients of the prizes. Again \$3,270 is a lot of money to be paying by cash but this may be what people prefer and easier to organise in advance.

Gail has indicated to be available to do the 2017 – 2018 accounts "all going well".

**IP Travel:** All players and CDM have booked their flights and have had their tickets reimbursed. NZ Bridge through Richard Solomon have refunded us very quickly. We have a slight shortfall (\$170.51) for various reasons, something the players for future IPs need to be made aware off.

In general, if your event attracts 14 or more tables, it is good practice to have two sets of boards available for each session.

# **Comments made during tournaments**

It has come to our attention that comments were made about a player who also scored in an event, which were suggestive that a good result was achieved by that player because that player had also done the scoring.

The player who made these comments has been spoken to and has apologized.

Please keep in mind that tournaments are run by volunteers who give up their time in order to give others a chance to play in an event. Most directors and scorers prefer playing over directing or scoring. Comments as they were made, even meant as a joke, may lead to these volunteers quitting.
