## **Review of Inter-Provincials:**

- Venue preference favour Hamilton
- Timing pre-National Congress
- Teams favour 3 pair teams; + 2 x Chef de Missions
- Travel favour NZ Bridge paying for travel
- Accommodation favour Regional Committees assisting where possible
- Format favour having a 'Final', if IPs scheduled pre-Congress

### Notes:

- 1) The discussion considered other interested players thoughts & comments
- 2) The Hamilton Venue & associated timing of the IPs, may encourage increased interest in trialing in our region
- 3) The Hamilton venue should ease administration of IPs
- 4) With a 'final' being held pre-National Congress, it should attract spectator interest

## **Review of Grading:**

- Agreed that the current determination of grading does require change to a simpler, more comprehensible system of criteria
- The attaining of 50 x A's or a collection of stars is a questionable qualification for promotion
- Favour the qualifications of 'Open' & 'Restricted Open' as used at National Congress
- Don't want to discourage playing, in order to drop rating points so as not to achieve change of division
