Agenda Items:

- 1. Judith received an email From John Skipper offering a zoom meeting to discuss any issues the Regional Committee have. Judith going to talk with him but no zoom meeting required at this stage.
- 2. Rubber Bridge. Our representatives, Pam Nisbet and Peter McCaskill are available on the new date in Feb. This has been confirmed with NZBridge.
- 3. Updated list of directors differed from what we had on OS website, so Lynne been confirming actual status of discrepancies with the clubs and NZ Bridge and getting our website aligned. Our web site should only list those that are qualified as they can then direct tournaments for other clubs.
- 4. Decision regarding Continuing with OS Congress to be made later this week once we have a clearer picture with regard to likelihood of reaching level 1 in time. Keeping to NZBridge guidle lines it should only be held in level 1.
- 5. Summary of club's numbers received needs to be read in context as it doesn't take into account the changes in population sizes in areas and the demographic age wise.
- 6. No one has paid for their OS Congress entries yet. Will hold off discussion on proceeding or cancelling until after Covid level announcement on Tuesday.
- 7. NZBridge have given Sonya Adams a schedule of responsibilities and that is under negotiation before she can be appointed to the role of Regional Bridge Mate for OS region.

Motion: "That we endorse Sonya Adams' appointment to the position of OS Regional Bridge Mate." Judith/Phil - Agreed

It is noted that we are being asked by NZ Bridge to approve the person and the role without seeing the role description.

Committee members to complete the survey re the RBM and return to Judith for compilation. We should put out a survey to our clubs re how they see our role.

8. Funding our IP team. Difficult for us to apply to a lot of the organisations that provide grants as we are not a registered charity. Our team are aware of the potential costs they may incur representing the region.
