RBM Report / Weekly Emails

It was acknowledged that Eunice Eccles had resigned her position as RBM for WB and was no longer employed by NZ bridge. NZB would like the committee to consider and give them feedback as to the role of RBM, how we see it, if we consider it to be of value and how we would like to see it. To be put on AGENDA for next meeting.

Online lessons.

Rona advised that she is now doing her Taupo club lessons online. She suggested that these be opened up to other WB clubs that were finding it difficult to run lessons under the current climate and suggested a trial whereby the lessons are paid for by individuals through the Compass Virtual Club, who then takes their percentage from the \$6 per student, and pays the balance to WBRC account. WBRC in turn pay Rona and Realbridge invoices, retaining the balance of around 60c per student that would be left over. This could then be used for some some other purpose to be decided in the future.

Rona then also suggested that the WBRC pay for her to obtain a zoom account, which was agreed, after establishing it was not possible to use Alister's NZB one

IP Trials

As the IPs are going to be online in 2022, it was discussed and agreed that the WB IP trials would also be held online. The preference would be Friday night and all day Saturday, with format depending on entries (pairs trials this year). All entrants would have to provide some evidence of partnership experience, eg 2 tournaments played together in the previous 12 months or regular club play.

Rona is to ask Mike Neels to possibly direct under supervision, or perhaps William.

Resignation

Jan Spaans resignation from his position as Secretary/Treasurer and member of the WBRC was accepted. A huge vote of thanks was offered by the remaining committee members for Jan's 11 years of service.

PROPOSED that Mereana Cullen be appointed to fill the vacancy on the Committee and also to act as Secretary/Treasurer Rona/Jo Carried Rona reminded us that regional elections were coming up soon.

Kelly Peirse Teams

Alan advised that the match committee were meeting tomorrow evening to decide whether this event would be held online or FtoF. There was no appetite from the committee to enforce a decision by the committee for this WBRC event.

Restricted Open Championship League

While NZB had withdrawn its support for restricted open tournaments to be for National Master and below, it was discussed that it was in fact not feasible to include only Provincial Master and below for the league, due to small numbers. It was agreed that WB can establish its own criteria for the league, but would have to eliminate tournaments where National master competitors could not play with their usual partner. It was agreed to drop the Restricted Open 8B in Hamilton from the list of eligible tournaments.
