Whilst there has been a focus in WBRC for funding the RC Teams this is not the prime motivator – we are also thinking of funding trial programs and perhaps extending others. The need to provide an annual business plan and associated budget is recogniseed but the WBRC wants to ensure that there are fund raising opportunities to try other projects – the Director initiative being an example.

Action: Alan to redraft note to NZB making it shorter and clearer.

- RC funding discussed and agreed to find minuted resolution to run the NI Pairs
  with express reason to assist funding. Note that the original selection of teams
  was for a siz person Team for the intermediates and 4 person for the other teams
  but offering them the option of an additional pair if they thought that
  necessary/desirable.
